First Daiwa House Multi-Tenant Logistics Facility Development in Northern Vietnam: "DPL Vietnam Minh Quang" Opening Ceremony

Daiwa House Industry Co., Ltd. (Head Office: Osaka / President and CEO: Keiichi Yoshii) is pleased to announce the completion of a multi-tenant logistics facility*1, DPL Vietnam Minh Quang (single-story building, lot area of 70,109.20 m², total floor area of 38,871.99 m²) in the northern Hung Yen Province of the Republic of Vietnam (hereinafter "Vietnam"). This facility has been under development since March 1, 2024, completed on December 26, 2024, with an opening ceremony held on February 27, 2025.

This project was executed through DH WHA Logistics Property Minh Quang Vietnam Co., Ltd., a joint venture between Daiwa House Industry and WHA Corporation PCL (Headquarters: Samut Prakan / Representative: Jareeporn Jarukornsakul; hereinafter "WHA"), the largest developer of logistics facilities and factories in the Kingdom of Thailand (hereinafter "Thailand").

Daiwa House Industry's first multi-tenant logistics facility in Northern Vietnam, DPL Vietnam Minh Quang, is conveniently located along a major road providing direct access to the center of Hanoi, approximately 45 km away. As the facility boasts excellent accessibility to Northern Vietnam's largest international airport and trade ports, it is in a highly convenient location for land, sea, and air logistics, making it suitable as an international trade hub.

Daiwa House Industry has been collaborating with WHA in Thailand since 2016. Together, we have

developed a total of 12 facilities across five projects, including logistics and commercial facilities. Additionally, we have been working together on the operation, management, and leasing of logistics facilities, launching our first overseas joint "on-site PPA" *2 project in Thailand in February 2025.

Going forward, Daiwa House Industry will continue to strengthen its collaboration with WHA and aim for further business expansion in the ASEAN region.

*2. A scheme where a third party installs solar power generation equipment on the roof or within the same premises leased from the building owner and supplies the generated electricity to the tenant companies of the building for a fee. PPA stands for Power Purchase Agreement.
